The expression SETTLER as well as Trustees used in the covenant shall mean and include their heirs, executors, administrators, assignees and representatives.

Whereas the Executant Settler herein is the Successor of the religious seat of his holiness Sant Tara Singh Ji who was discharging the duties as Sant of Dera Santpura Danna. During his life time he established religious and social institutions centre for the teaching of Gurumat and imparting education. After the demise of Sant Tara Singh Ji Sant Khushal Singh and Sant Gurdit Singh carried on the activities of the institution of Dera Santpura Danna. After the demise of Sant Gurdit Singh, Sant Gurbaksh Singh, in his younger age managed the said institution socially as well as religiously. Due to the efforts of Sant Gurbaksh Singh (Settler herein), a Primary School was granted by the Govt. for the education, welfare of the residence of so many villages near by Dera Danna Muzeffrabad. Later on it was upgraded to High School before partition and now a days the same is upgraded to college now in Pakistan occupied Kashmir.

After partition Sant Gurbaksh Singh settled in Jammu and established Gurudwara Santpura Danna in Nanak Nagar Sector -7 Sant Gurbaksh Singh Ji created a trust duly registered with Sub Registrar 2nd Munsiff on 2-04-2011. After the demise of Sant Gurubaksh in the year 2012, his grandson Sant Tejwant Singh, became the settler in managing Principal Institution Santpura Danna and by unanimous decision of the Board of

NOW THIS DEED OF TRUST WITNESSETH AS UNDER:

1. NAME OF THE TRUST :-

The name of the trust shall be Sant Pura Danna Chaitable Trust.

2. Office of the Trust :-

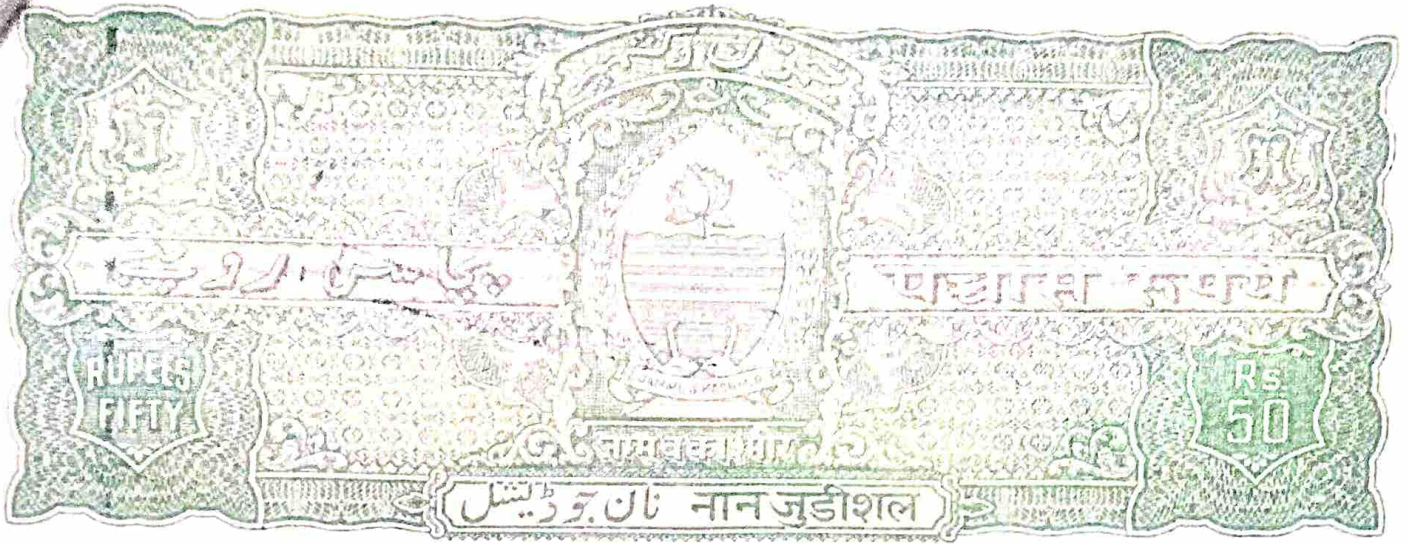
The Head Office of the Trust shall be situated at Gurudwara Santpura Danna Nanak Nagar Sector-7 for carrying out the purposes mentioned herein.

3. THE OBJECTS OF THE TRUST SHALL INCLUDE THE FOLLOWING :-

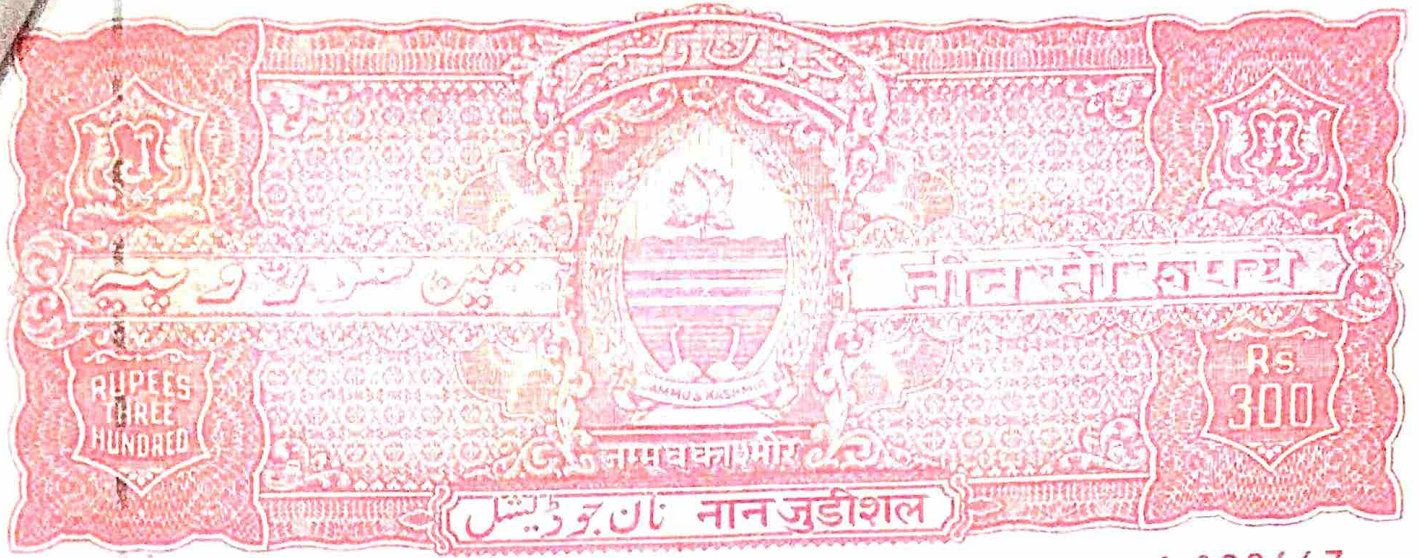
- b. To set up, establish, maintain and managed, educational, technical, vocational institutions, Schools and colleges and Technical College under the name of Sant Pura Danna College.
- c. To accept, in cash or kind, donations subscriptions, grants and presents amounts, collect, dividends, interests and other income for the Trust fund only.
- d. The Trust is a general Trust. The income and property of this Trust shall be employed towards the promotion and development of the objectives of the Trust.
- e. To acquire movable and immovable properties for the purpose of the Trust and to raise and construct buildings on the immovable property thus acquired and to dispose off Trust property in case that

have the powers to incorporate other persons as trustees shall not exceed ten.

Power and duties of the board of trustees:

1. The whosoever succeeds as Sant of Santpura Danna shall step into the shoes of Settler.
2. The trust may receive donations of money and or properties when received shall be at the disposal of the trust.
3. The trustees may open and operate current or saving account or many other accounts with any scheduled bank or banks and all such bank transactions or other transactions related to money shall be carried on by settler and other Trustees as mutually decided by the Board of Trustees.

Custody of Documents :-

That the Gurudwara Sant Pura Danna, Santpura Danna Community Hall and Santpura Danna Dispensary situated at Sector-7 Nanak Nagar, will be the exclusive property of the trust.

The Trustee no.1 or any other trustee if so authorized by the Board of Trustees shall have the custody of documents, deeds or title relating to school properties and investment and the books of the accounts and other
