- 2. The school has shown CWSN toilets for boys and girls only at the ground floor. It should provide for the same on every floor, with proper, permanent signage and submit compliance within 3 months on SARAS portal. The ramps constructed by the school are not even and without handrails, posing a danger to safety of CWSN. The school should ensure proper construction of ramps as per specifications of RPwD Act and submit compliance within 3 months. The school should ensure construction oif lift within next 3 months and submit compliance on SARAS.
- 3. The school shall ensure training of its teachers with CoE Chandigarh within 3 months and submit the compliance on SARAS.
- 4. The school library is still inadequately stocked, with neither the librarian or Principal aware of the kind of books required in a library. The composite science lab has no proper seating area. The school shall follow the SoPs issued by the Board for labs, library and sports facilities and submit compliance within 3 months on SARAS portal.
- 5. The school shall get all the mandatory certificates renewed periodically.
- 6. The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
